Back in June the Minnesota Commissioners of Health and Human Services declared a more limited state public health emergency to ensure Minnesotans on SNAP continued to receive the max benefit amount for as long as there was a federal health emergency in place, so I don't think they'll be phasing out soon, but the state does have to apply every month to extend those benefits.
